May I request consideration to relieve Juharto A. Mantato as the Division SPed Schools' Representative, and replace him with the Division SPed Coordinator, Dr. Nida O Padrique, one of the Division's Public Schools District Supervisors.

This request of change of assignment are due to the following reasons:

a) Mr. Juharto A. Mantato has just been designated as the School Head of Datu Siang National High School. This is his first school head assignment, and he has to render his full time managing and leading the school. He has never been a SPed teacher and has no training in handling Special Education Program.

b) On the other hand, Dr. Nida O. Padrique is a Public Schools District Supervisor of District 1 with only one very large public school namely Cotabato City Central Pilot Elementary School (CCCPES). She is a recognized SPed coordinator of MBHTE Curriculum Division for she is the one attending the SPed trainings and meetings of MBHTE program. with the expertise of Dr. Padrique, she can contribute a very substantial input for the protection of rights of special children, being a National and Regional Trainer of K to 12 Curriculum on SPed.

This repositioning will help both Mr. Mantato and Dr. Padrique focus on their deliverables based on the major assignments given to them. Moreover, this request consideration is for the best service to give for the Bangsamoro learners.
