- 1. The Philippine government upholds the efficiency of the delivery of services to the public through the enactment of Republic Act 9485 in 2007. Otherwise known as the Anti-Red Tape Act of 2007, it mandates all government units and governmentowned corporations to expedite transactions and or set fixed time-frames or deadlines for certain transactions. It emphasizes the reduction of red-tape and corruption besetting the government agencies.
- 2. In the same context, the Bangsamoro government anchored on its policy on MORAL GOVERNANCE highly commends the provision of quality services to different layers of clientele among the different ministries and offices in the region. It requires efficient delivery of public service where it responds accurately to the needs of the client which the public employee is serving. To keep abreast with such policy, it is a precedent to define the functions, relationship among the different positions within and across departments. It will identify the role and functions of each employee to avoid overlap of functions, miscommunications and delays of transactions.
- 3. Given the above, the Ministry of Basic, Higher and Technical education, with support from the Pathways will have a Charter Development Workshop for Basic Education offices. It is a document that defines the purpose, focus and reason for existence of a group or an organization. It sets the overall direction on how the office will discharge its function.
