- In case of deceased ISAL teacher-asaatidz, the claimant shall provide the following:
  - Affidavit of Legal Heir
  - Affidavit of Undertaking
  - Original copy of Death Certificate
  - Original DTR & Accomplishment report
  - Affidavit of surviving spouse (if claimant is spouse)
  - Original Marriage Contract (if claimant is spouse)
  - Original copy of Certificate of Live Birth (If claimant is children)
  - Two (2) valid Government IDs
  - Deployment order
