 Pursuant to Article IX-C, Section 2 (4) of the 1987 Philippine Constitution, the Commission on Elections (COMELEC) has the power to deputize law enforcement agencies and instrumentalities of the government for the exclusive purpose of ensuring free, orderly, honest, peaceful, and credible elections.

- The Ministry of Basic, Higher and Technical Education (MBHTE) is one of the agencies deputized by COMELEC as embodied in the recently signed MBHTE-COMELEC MOA for the conduct of the first National and Local Elections in BARMM.
- 3. In view thereof, and to ensure compliance with and enforcement of all orders and instructions relative to the election duties and responsibilities as enunciated in COMELEC Resolution No. 10727 promulgated last November 10, 2021, and to amply prepare the frontliners of the forthcoming May 2022 National and Local Elections, while still facing the COVID 19 Pandemic, the MBHTE will be conducting an Orientation for those personnel (public school teachers and non-teaching personnel) who are qualified and signified their intent, willingness and availability to render election service in the forthcoming elections.
- The orientation shall address related issues and concerns about elections.
 Among others, it specifically aims:

a. To provide an overview of the MBHTE- COMELEC MOA for conduct of May 2022 National and Local Elections in BARMM;

- b. To revisit COMELEC issued Resolutions pursuant to the conduct of elections.
- c. To discuss the duties and responsibilities of the members of Electoral Boards (EB) and the support staff before, during and after elections.
- d. To discuss various jurisprudence on election related cases and electioneering; and
- e. To cater queries and concerns regarding election related matters.
- 5. In adherence with the health protocols and guidelines set by authorities, the orientation shall be done by cluster and the number of participants attending the face-to-face orientation will be reduced. Others who cannot be accommodated shall join the activity through online flatform. The SDOs concerned shall ensure the participation of all involved personnel from their Division.
