SUBJECT: **VALIDATION OF IDENTIFIED SCHOOLS FOR THE PILOTING OF LIMITED FACE TO FACE LEARNING MODALITY CLASSES IN ISLAND DIVISIONS**

DATE : **February 3, 2022**

1. The IMMC (Inter-Ministry Memorandum Circular) for the Safe Opening of Limited Face to Face Classes in BARMM has already been signed by the concerned ministries. The IMMC is the contextualized version of the National Joint Memorandum Circular (JMC No. 1, s. 2021) issued by the Department of Education (Dep-ed) and Department of Health (DOH).
2. Through the use of School Readiness Assessment (SRA) and School Safety Assessment Tool (SSAT), schools were identified to participate in the pilot testing for face to face classes
3. However, it needs validation before the final endorsement to the Regional IATF. Teams from MBHTE Regional office shall do the validation activity on schools divisions in mainland to wit; Tawi-tawi, Sulu, Lamitan and Basilan.
4. The Division Superintendents are requested to invite other stakeholders such as the Municipal Health Unit, the Local Government Unit and the local IATF while the school heads will request the presence of Barangay Local Government Unit and the PTCA or parents representatives and other concerned.
5. The activity shall be conducted on February 7 – 13 ,2022 inclusive of travel on the identified schools division.
