DEVELOPING A CASE STUDY FOR AKAP

DATE August 19, 2022

Republic of the Philippines Juning is Helper to Mustim Mindanao INFORMATION AND COMMUNICATIONS DIVISION

- 1. The Ministry of Basic, Higher and Technical Education (MBHTE), through the Access Technical Working Group (TWG) and the M&E Unit of the Directorate General of Basic Education (DGBE), and with support from the Australian Government through the Pathways Program, will conduct a case study writing on the Abot Kaalaman sa Pamilyang Bangsamoro (AKAP) Program.
- 2. The main objective of the case study is to document the journey of the AKAP Program especially to highlight the successes of the ministry's flagship program on access to education in underserved and unserved barangays, generate stories of significant change, and lessons learned.
- 3. Specifically, the case study aims to:
 - a. document AKAP milestones and key processes from its inception to its current state:
 - b. consolidate information on how the different elements of the intervention from conceptualization to implementation and how these have addressed the issue of lack of access to education in unserved and underserved barangays (Geographically Isolated, Disadvantaged, and Conflict-Affected Areas);
 - c. examine the causal links between the AKAP interventions and observed effects on learners, certain sectors, institutions, and communities; and
 - d. highlight not only the success of the initiative (good practices) but also to identify challenges and difficulties, allowing an opportunity to gather lessons learned and provide recommendations.
- 4. The case study will be used for learning reflections, both internally and with key partners, to distill lessons learned, draw recommendations for policy and decision-making, and strengthen intervention design on access to education. In collaboration with the Pathways Program, the rich information that will be generated will be translated into different knowledge management products.
