In line with the passage of Republic Act 11106, An Act Declaring the Filipino Sign Language as the National Sign Language of the Filipino Deaf which the Department of Education (DepEd), together with other national and local government agencies involved in the education of the deaf is mandated to develop, a policy on the use of Filipino Sign Language as medium of instruction and learning was drafted last August 8-12, 2022. Consequently, the draft policy will be reviewed and substantiated in a workshop to be conducted by the Bureau of Learning Delivery – Student Inclusion Division (BLD-SID) on October 12-14, 2022 at Ritz Hotel, Porras St., Bo. Obrero, Davao City.

Participants to the activity are one (1) Education Program Specialist for Special Education (SPED) and one (1) Filipino Sign Language (FSL) interpreter to be identified by the Regional Offices. The participants must register through this link - https://tinyurl.com/Validation-FSL on or before October 5, 2022. Enclosed is the number of participants per region.

All participants are expected to bring their own laptops and vaccination cards. They should be at the venue on Day 1, October 12, 2022 (Wednesday). The first meal is dinner of Day 0, October 11, 2022 and the last meal is lunch on Day 3, October 14, 2022 (Friday).
