SUBJECT : **AUTHORIZED SIGNATORIES OF REGIONAL MADRASAH
 GRADUATE ACADEMY (REMACADEMY)**

DATE : October 6, 2022

- Section 142 of the Bangsamoro Autonomous Act No. 018 otherwise known as the Bangsamoro Education Code provides that "**Jurisdiction over BARMM- supervised post-secondary institutions.** - The Ministry has jurisdiction over BARMM- supervised or non-chartered state-supported post-secondary degree- granting vocational and technical programs, and tertiary institutions shall be transferred to the Ministry... **The Ministry shall also have jurisdiction over local colleges and universities under its territorial jurisdiction, including the existing Regional Madrasah Graduate Academy.**"
- Pursuant thereto, the Regional Madrasah Graduate Academy (REMACADEMY) shall be within the jurisdiction of the Ministry of Basic Higher and Technical Education- Bangsamoro Autonomous Region in Muslim Mindanao (MBHTE- BARMM) and that the Ministry shall have the power to organize the Board of Trustees of the above mentioned BARMM-supervised or non-chartered state-supported higher education institutions after massive public consultations.
- Now therefore, pending the appointment the organization of the Board of Trustees of REMACADEMY, and in the exigency of the service, this Ministry designates the following officials as its authorized signatories:
