SUBJECT : **GUIDELINES ON THE ISSUANCE OF DESIGNATION ORDERS**

DATE : 3 November 2020

1. This memorandum order is released to inform all schools division superintendents that all designations issued by the former DepEd Regional Secretary Rasul Mitmug are hereby on a hold over capacity until issuance of a new or a subsequent designation order stating the replacement of the previous designated official. Thus, no designation order from the previous administration shall be replaced unless an issue, impediment or problem proving his/her incapacity to act accordingly in the designated position given has been proven.
2. In addition, any issue, impediment or problem concerning a designated official must be formally raised to the Office of the Minister for further investigation and due process. No further actions must be made in the division level without the information and approval of the Minister
3. Please be reminded that only the MBHTE Office of the Minister is authorized to issue a designation order. The superintendent may recommend an official however, the recommendation is still subject for the review and approval of the Office of the Minister based on the given qualifications and needs. Also, designations for Schools Division Superintendents and Assistant Schools Division Superintendents are in the jurisdictions of the BARMM Interim Chief Minister. The MBHTE Minister can only designate officials subordinate to the aforementioned positions.
4. Effectivity of designation orders shall remain in full force until revoked by the Office of the Minister anytime should it be deemed necessary. Designation orders shall also be entitled to modifications, amendments and/or repeals of all other issuances inconsistent herewith.
