- 1. Pursuant to the mandates and policies of the Bangsamoro Education Code (BEC) and its 12-Point Education Agenda, the Ministry of Basic, Higher and Technical Education (the Ministry) through its Directorate General for Basic Education will hold a Learning Session on the Protection of Education in Armed Conflict and the Safe Schools Declaration (SSD) on February 27, 2023 at 8:30 am at Hotel Paragon and Restaurant, Cotabato City. In particular, Section 39 (k) of the BEC provides that the Bangsamoro Government shall recognize the right of learners in school/education institutions "to be protected from all forms of violence and physical and other forms of humiliating and abusive treatment"; Section 85 mandates the Ministry "to develop, implement, and monitor specific minimum standards governing school infrastructure, including provisions for a safe, secure, and friendly learning environment"; Section 165 mandates the Ministry "to adopt a Peace Education Curriculum designed to instill the culture of non-violence, social justice and respect for human rights, freedom and inclusivity"; and finally, the Ministry set "Schools safe for learning and development" as one of its priority agenda.
