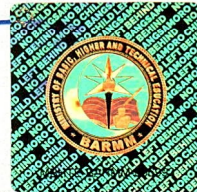

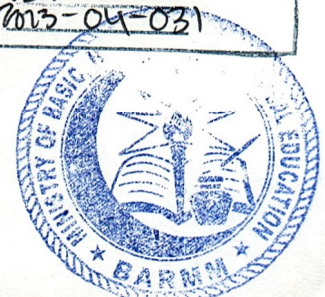
SUBJECT : PROHIBITION OF SOLICITATION TO ALL MBHTE EMPLOYEES AND PERSONNEL TO FINANCE ANY OFFICIAL OR UNOFFICIAL ACTIVITIES OF THE MBHTE

DATE : March 30, 2023

- In line with the Bangsamoro Autonomous Region's principle of Moral Governance and the Ministry of Basic, Higher and Technical Education's (MBHTE) Service Excellence, this office is strictly prohibiting solicitation, monetary or non-monetary, voluntary or non-voluntary, from permanent or non-permanent employees of the MBHTE to finance any official or unofficial activities of the Ministry.
- This includes Solicitation and Bribery for Promotion and Application to any Position. Hence, under the 2017 Rules on Administrative Cases in the Civil Service, **soliciting or accepting directly or indirectly any gift, gratuity, favor, entertainment, loan or anything of monetary value in the course of one's official duties or in connection with any operation being regulated by, or any transaction which may be affected by the functions of one's office is a grave offense punishable by dismissal from the service.**
- All activities of schools, units, sections, divisions, provincial offices, training centers, bureaus, and directorate offices shall be financed by the Central Office and/or their respective Offices' MOOE, as applicable.
- The Ministry shall accept any complaint, anonymous or named, against any MBHTE official or employee accused of requiring solicitation.
