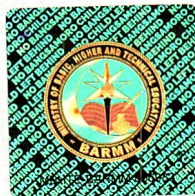

SUBJECT : **DISCUSSION OF THE FISCAL YEAR 2024 BUDGET PREPARATION**

DATE : March 30, 2023

1. The Ministry of Finance, and Budget and Management released the Bangsamoro Budget Circular No. 2023-01, which calls for all the heads of Ministries, Members of the Parliament, and Bangsamoro Offices to start developing the budget for Fiscal Year (FY) 2024, anchored on the 2nd Bangsamoro Development Plan (BDP) 2023-2028.
2. The 2nd BDP outlines six development goals and identified eight identified strategies to achieve the goals.
3. Consequently, the Ministry of Basic, Higher and Technical Education responds to the call by crafting budgets based on the priorities stipulated in the 2nd BDP.
4. To ensure the implementation-readiness of the proposals, the Ministry's Planning Division (PD) will conduct a **Discussion of the FY 2024 Budget Preparation** with representatives from different subsectors and division offices of the Ministry.
