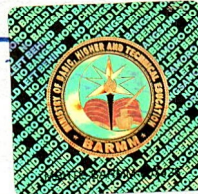

SUBJECT : **WORKSHOP ON THE FINALIZATION OF GUIDELINES FOR ISSUANCE OF PTO FOR PRIVATE MADRASAH AND GRANTING OF FINANCIAL SUBSIDY**

DATE : April 19, 2023

1. The Ministry of Basic, Higher and Technical Education's (MBHTE) Directorates for Madaris Education (DGME) and Basic Education (DGBE) with support from the Australian Government through the Education Pathways to Peace in Mindanao, will be conducting a **Workshop on the Finalization of Guidelines for Issuance of PTO for Private Madrasah and Granting of Financial Subsidy** on April 26-28, 2023 at BPDA Conference Hall, Cotabato City.
2. These policy guidelines are limited to the Private Madrasah both formal and non-formal and Special Education Institutions such as Traditional Madrasah (which require attendance during weekends, Chapter 1, Section 49 of BEC) and Markaz Tahfidz Al- Qur'an within the Bangsamoro Autonomous Region in Muslim Mindanao.
3. Specifically, the activity seeks to:
 - a. identify issues, concerns, and challenges concerning the requirements of accreditation and come up with collaborative possible recommendations;
 - b. discuss and consolidate the results of the series of consultations conducted with 134 Private Madaris, Legal Office, and education experts and testing the tools and readiness of the Private Madrasah;
 - c. design the system for the quality management of the Madrasah Establishment;
 - d. finalize the Composition of the Monitoring and Validation Composite Team in the Issuance of PTO for Formal, Non-Formal, and Special Education Institutions;
 - e. finalize the two-draft policy; and
 - f. establish coordination with Directorate General for Basic Education.
