- 1. The Ministry of Basic, Higher and Technical Education (MBHTE), through its Directorate General for Madaris Education (DGME), is strengthening the Madrasah Education System in the entire BARMM and part of it is providing government subsidies and other support to private Madaris including, but not limited to the scholarship for qualified learners, the operational cost of the schools, and support to the special madrasah development program.
- 2. In connection with the Regional Memorandum (RM) No. 1335, series of 2022 issued last November 8, 2022, with the subject Conduct of the Monitoring and Validation of the Private Madrasah Applying for Financial Assistance and Renewal of Permit to Operate and RM No. 192, series of 2023 regarding the Application for Renewal of Government Permit to Operate, the MBHTE-DGME's Education Quality Assurance Division will resume the Conduct of Monitoring and Validation of Private Madrasah Applying for Government Subsidy and Conduct of Ocular Inspection to Private Madrasah Applying for Renewal of Permit to Operate from May 2023 to August 2023.
- 3. The activity aims to:
 - a. monitor compliance of Madrasah with government recognition and permit to operate to existing policies and guidelines;
 - b. validate and evaluate operations of Madrasah before granting financial assistance for 2022-2023 and permit to operate for the school year (SY) 2022-2023 and 2023-2024;

- c. evaluate the performances of ISAL teachers-asaatidz, K to 12 Teachers, and learners in relevance to the implementation of Madaris programs, projects, activities, and services to the respective Private Madrasah; and
- d. perform an evaluation of the Madrasah for planning, program implementation plans, and development of a data management system.
- 4. The schools division superintendents, Madaris Education Division Heads, and Planning Officers of the Conduct of Monitoring and Validation to Private Madrasah Implementing Refine Standard Madrasah Curriculum, together with the MBHTE DGME Monitoring and Validation Composite Team, are hereby informed of the activity.
