- 1. In consonance with Republic Act 11054 also known as the Bangsamoro Organic Law, the authority to approve the establishment of public and private elementary and high schools and learning centers is vested upon the Minister of the Ministry of Basic, Higher and Technical Education.
- 2. Consequently, a Technical Working Group (TWG) was constituted to conduct an evaluation of required documents, ocular inspection, and provide findings of the process through the issuance of Regional Memorandum No. 1101 series of 2021 dated September 20, 2021.
- 3. Based on the first batch of documents for the renewal of PTO that the TWG received and processed, it was observed that only around 12% of the private schools actually applied. To improve this and address other related concerns, the TWG will design projects and activities to strengthen our system and practices. In preparation for our planning, we need first to establish a database of all private schools operating in the Bangsamoro Autonomous Region in Muslim Mindanao.

In collaboration with your respective Planning Officers and Division Supervisors Quality Assurance Officers, please complete the attached DATA-GATHERING-TEMPLATE and submit the attachments such as a photocopy Certificate of Government Recognition or the latest PTO. The deadline for submission is May 26, 2023.
