- 1. Pursuant to Chapter VIII, Section 27 of the Bangsamoro Administrative Code, one of the specific powers and function of Madaris Education is to develop appropriate curricula, quality textbooks, and teaching materials for Madaris Education that will establish an integrated system of education reflecting the ideals and aspirations of the Bangsamoro people.
- 2. In order to push reforms in the education system, particularly the curriculum, and its delivery, the Ministry of Basic, Higher, and Technical Education is hereby constituting a 3 Sub-Committees on the Development of the Islamic Studies and Arabic Language (ISAL) Curriculum.
- 3. The roles and functions of each sub-committee are listed hereunder, to wit:

3.1 Technical Sub-Committee

- Review the technical aspects of the ISAL Curriculum development to ensure that the draft ISAL Curriculum is technically correct and aligned to the curriculum used by the National Office.\
- Ensure that the ISAL Curriculum gives emphasis on the alignment of the competencies vertically and horizontally, and it is based on the Bangsamoro Education Code (BEC).
- 3.1.3 Ensure that ISAL Curriculum integrates the 7 Principles of BEC and emphasizes the BARMM context.
- 3.1.4 Review and ensure that the competencies focus and give emphasis on the spiral progression, and must be suitable and appropriate to the learner's age or grade level blic of the Philippines

- 3.3.1 Review the content of the ISAL Curriculum to ensure that every content or competencies stipulated in the curriculum are suitable and appropriate to the learner's age and grade level.
- **3.3.2** Review and ensure that the topics, skills, and competencies utilized per subject and per grade level are suitable and appropriate to be taught in a particular grade level.
- 4. It does not necessarily mean that a particular member of a particular sub-committee will focus only on their roles and functions. Any member of any sub-committee is free to express their thoughts, ideas, suggestions, or recommendations in a very constructive manner if they find inappropriate words or phrases, as well as the processes in the ISAL Curriculum development.
- 5. All supplies, materials, food, transportation, equipment, and other financial requirements that may be needed by the sub-committee members and service provider during joint-meetings shall be included in the amount of Contract of Agreement, subject to the existing accounting and auditing rules and regulations.
