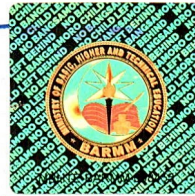

- This is in view of Regional Memorandum No. 540 series of 2023 re: Participation of the 2023 Palarong Pambansa Transportation Guidelines with reference to DepEd memorandum no. 035, series of 2023 re: **2023 Palarong Pambansa General Information, and the Technical Rules, Regulations and Guidelines on Sports** through DepEd Memo No. 005, series of 2023 titled **Conduct of the 2023 Palarong Pambansa** that is scheduled from July 28 to August 5, 2023 which will be hosted by Marikina City local government unit together with the DepEd-National Capital Region (NCR) office and the Schools Division Office (SDO) of Marikina City.
- Thus, due to the surge of transportation costs particularly in airplane ticket fares, an additional budget for transportation allowance for the participants and officials for the conduct of Palarong Pambansa in Marikina City shall be provided amounting to **PHP 15,000.00** per pax.
