- 1. Monitoring and Evaluation (M&E) is a continuous management function to assess if progress is made in achieving expected results, to spot bottlenecks in implementation, and to highlight whether there are any unintended effects (positive or negative) from a project implementation plan, program, and its activities.
- 2. The launching of the Bangsamoro Education Reform Development Plan (BERDP), the Bangsamoro Development Plan (BDP) 2023-2028, and the DepEd Basic Education Development Plan with its M&E Framework need a functional M&E System in the MBHTE Basic Education Directorate that will tremendously affect the performance of the schools division offices (SDOs) as this will urge performance and continuous improvement. This will propel all the SDOs and schools to upscale their performances and strive towards achieving their targets and desirable outcomes.
- 3. In this aspect, the M&E Section of the MBHTE Basic Education will see to it that regular audit performance report will be done to maintain the surge towards productive output and milestone achievement of each SDOs and schools.
- 4. One of the audit performance reporting systems that will be in-place is the Monitoring and Evaluation Reporting and Adjustment (MERA) System. It is both a strategy and a mechanism, participative and collaborative, and involves the collection, validation, analysis, and reporting of appropriate, relevant, and accurate information necessary for the adjustment of work plans and strategies.

- 5. It provides the division and school management an information on the implementation of the programs and projects which serve as basis for plan adjustment information on the organizational health and performance which serve as basis in determining appropriate strategies and interventions to improve organizational effectiveness and resource support.
- Thus, the Directorate General for Basic Education's Quality and Assurance Division-M&E Section will conduct a Workshop on the Division Monitoring, Evaluation, Reporting and Adjustment (DMERA) on July 24-27, 2023, at Bay Plaza Hotel, Pagadian City.
- 7. This activity aims to:
 - a. orient the SDO CID, M&E, and Planning Officers on the conduct of the DMERA;
 and
 - b. craft plans on the institutionalization, dissemination, publication, and cascading of the DMERA.
- Participants in this activity are the SDO Curriculum Implementation Chiefs (Designate), Planning Officers (PO), and M&E Officers (MEO). Travel expenses of participants from the SDOs shall be charged to their respective schools division's MOOE.
