SUBJECT : **HOME GROWN SCHOOL FEEDING (HGSF) LESSONS LEARNT WORKSHOP**

DATE : July 20, 2023

1. The Ministry of Basic, Higher and Technical Education (MBHTE), through its Health and Nutrition Unit (HNU), will be implementing the School-Based Feeding Program (SBFP) for FY 2023 integrating the Home Grown School Feeding (HGSF) to the seven (7) municipalities of Maguindanao del Sur and Maguindanao del Norte as models of this program.

Consequently, Nurses-in-Charge and school nurses of the seven (7) model municipalities are directed to attend the **HGSF Lesson Learnt Workshop** on Tuesday, July 25, 2023, in Cotabato City (specific venue shall be communicated directly to the participants once finalized).
