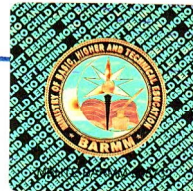

SUBJECT : **Technical Working Group for the Drafting of the Implementing Rules and Regulation of the Parliament Bill No. 31, otherwise known as the "Bangsamoro Regional Institute for Higher Islamic Studies"**

DATE : **August 11, 2023**

1. During the First Regular Session of the Second Parliament, the Government of the Day introduced Parliament Bill No. 31 (A Cabinet Bill), entitled "An Act Creating the Bangsamoro Regional Institute for Higher Islamic Studies Repealing Muslim Mindanao Act No. 164, otherwise known as the Regional Madrasah Graduate Education Act of 2003, providing funds therefor, and for other purposes".
2. In accordance with Bill No. 31, the Ministry of Basic, Higher and Technical Education of the Bangsamoro Autonomous Region in Muslim Mindanao (MBHTE-BARMM) shall be responsible for the formulation of its Implementing Rules and Regulations (IRR). For this purpose, a Technical Working Group (TWG) shall immediately be organized following the passage of Parliament Bill No. 31 into law.

3. The TWG shall draft the necessary Implementing Rules and Regulations and upon its approval, a copy of such IRR shall be furnished to the Parliament within sixty (60) days from the passage of Bill No. 31 into law.
4. The TWG shall be lodged under the Legal and Liaison Division of the MBHTE-BARMM, with the following composition:
