- As stipulated on the Implementing Rules and Regulations of the Bangsamoro Education Code, Section 78, the engagement of elders and other community members in the teaching-learning process, assessment, and management of the initiative, recognition, and continuing practice of the community's ILS; and the rights and responsibilities of ICCs.

In response to these mandates, the Ministry's Bureau of Indigenous Peoples Education (BIPED) will conduct a Consultation for the Development of Framework and Guidelines for Engagement of Elders and Community Members in IP Education on September 20-21, 2023.
