- As defined in the Department of Education Order No. 44, s. 2015 Guidelines on the Enhanced School Improvement Planning (SIP) Process and School Report Card (SRC), the SIP is a roadmap that lays down specific interventions that a school, with the help of the community and other stakeholders, will undertake within a period of three (3) consecutive school years.
- 2. Pursuant to the Ministry of Basic, Higher and Technical Education's (MBHTE) mandate to provide access to and deliver quality education to the Bangsamoro learners, the Office of the Directorate General for Basic Education's (DGBE) School-Based Management (SMB) Division, with support from the Australian Government's Education Pathways to Peace in Mindanao Program, is set to conduct a Development of SIP Guidelines on October 24-28, 2023 (inclusive of travel time) in Davao City (specific venue shall be communicated directly to the participants once finalized).


