CONSTITUTION OF TECHNICAL WORKING GROUP FOR WRITING THE

GUIDELINES FOR THE ESTABLISHMENT OF PUBLIC MADRASAH

DATE

October 26, 2023

- 1. As mandated by RA 11054 or the Bangsamoro Organic Law, the Bangsamoro Transition Authority enacted the Bangsamoro Autonomy Act No. 18 also known as the Bangsamoro Education Code of 2021, where Section 3 stated that "This Act shall apply to Bangsamoro Education Systems consisting of all education systems including formal, non-formal and informal, public, and private learning institutions, in all levels, basic, higher, technical and Madaris education." It further discussed the establishment of the Public Madrasah System in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) in sections 91-96.
- 2. In this connection, the Ministry of Basic, Higher and Technical Education (MBHTE), through its Directorate General for Madaris Education (DGME) is hereby constituting the Technical Working Group (TWG) for writing the guidelines for the Establishment of Public Madrasah.
- 3. The purpose of these guidelines is to ensure:
 - a. the implementation of the quality of madrasah governance and educational services for public madrasahs;
 - b. the madrasah to be established, merged, converted, and named/renamed and the madrasah annexes separate from their mother madrasah are in accordance with the Ministry standards to enhance the delivery of basic education; and
 - c. the establishment of the minimum standards to operationalize, supervise, monitor, and evaluate the public madrasah operations.
