1. The Office of the Directorate General of Madaris Education (DGME) has issued an urgent directive to enforce Sections 119, 120, and 121 of the Bangsamoro Education Code, mandating a comprehensive regulatory inspection of private madrasahs by a designated composite team. This directive necessitates a special ocular inspection of identified private madrasahs in Basilan Province, commencing on **November 12, 2023**, and concluding on **November 16, 2023**.
2. The primary objective of this inspection is to evaluate the eligibility of these applicants (private madrasahs) for the Transitional Development Impact Fund (TDIF).
3. The private madrasahs scheduled for this special ocular inspection are outlined in Annex A.
4. The assigned team is entrusted with the responsibility of conducting the ocular inspection in Basilan Province, adhering to their designated tasks as detailed in Annex B. All relevant parties are advised to take note of this directive and ensure full compliance with the scheduled inspection.
