- 1. Considering the extensive number of policies and guidelines to be developed, it is essential to establish priorities from a program perspective. The prioritized guidelines include the Quality Assurance system, which serves as an essential component of the Madrasah Establishment System. The implementation of Madrasah-Based Management (MBM) is also critical for supporting quality teaching and learning.
- 2. In connection with this, the Ministry of Basic Higher and Technical Education through its Directorate General for Madaris Education (DGME) with support of Education Pathways to Peace in Mindanao will conduct a Madrasah-Based Management (MBM) policy development Workshop on November 28 to December 2, 2023 (inclusive of travel dates) in Davao City.
- 3. Participants in this activity are from the MBHTE Regional Office, representatives from the schools division offices (SDOs) and schools, both from the DGME and the Directorate General for Basic Education (DGBE), representatives of accredited madrasahs ready to be the models for MBM implementation.
- 4. At the end of the activity, participants are expected to:
 - gained a better understanding of the MBHTE SBM Framework.
 - developed policy contents for Madrasah Inclusive SBM Implementation, and
 - established an agreed timeframe for actions on guideline endorsement by the Minister.
