**SUBJECT :** **SUBMISSION OF THE PRE-WORK PROGRAM IMPLEMENTATION PLAN (PIP) FOR THE FY 2024**

**DATE :** January 4, 2024

1. The General Appropriations Act of the Bangsamoro 2024 is already approved by the Bangsamoro Parliament. The Education Sector remained the top priority of the Bangsamoro Government with the Ministry of Basic, Higher and Technical Education (MBHTE) getting the lion's share of the budget for 2024.
2. The budget of the MBHTE serves as the bloodline to fulfill the Bangsamoro Government's mandate and other responsibilities to build and deliver an education system that is relevant and responsive to the needs, ideals, and aspirations of the Bangsamoro people.
3. As per Bangsamoro Expenditure for Fiscal Year (FY) 2024, the ministry's budget is set at **PHP30,231,210,027.00**. The budget allocation will address the disparities in access, quality, equity, and governance of education and shall provide a competitive workforce in the future.
4. To ensure the timely approval and implementation of the different programs for FY 2024, all operating systems and directorates of the ministry are hereby advised to formulate a Pre-work Program Implementation Plan (PIP) for FY 2024.
5. The coverage of the PIP is as follows:
  - a. General Administration and Support (GAS) with a maximum increase of 5% of the previous year's allocation
  - b. Support to Operations (STO) fund with a maximum increase of 5% of the previous allocation
  - c. Operations fund
6. Attached is the new template of the PIP. This shall be submitted **on or before January 26, 2024**, through the Planning Division at email address [mbhteplanning@yahoo.com](mailto:mbhteplanning@yahoo.com).
