SUBJECT: SUBMISSION OF HIGHER EDUCATION DATA FOR THE BANGSAMORO

EDUCATION MANAGEMENT INFORMATION SYSTEM (BEMIS)

DATE : May 30, 2024

 Section 16 of Republic Act No. 11054 otherwise known as the Bangsamoro Organic Law (BOL) states:

Integrated System of Quality Education. - It shall be a top priority of the Bangsamoro Government to establish, maintain, and support a complete and integrated system of quality education, which shall be a subsystem of the national education system...

Any school, college or university existing in the Bangsamoro Autonomous Region as of the effectivity of this Organic Law, and such other schools and institutions that may be established hereinafter shall be deemed integral components of the educational system of the Bangsamoro Autonomous Region, and shall be governed by their respective charters...

The Bangsamoro Government shall supervise and regulate private schools, including sectarian and nonsectarian institutions of learning in any level...

- 2. The Bangsamoro Education Management Information System (BEMIS) is an integrated data management system of the Ministry of Basic, Higher and Technical Education (MBHTE) that is being finalized. It encompasses management data from the Office of the Minister and the four (4) MBHTE directorates Basic, Higher, Technical, and Madaris Education.
- 3. The BARMM Higher Education Management Information System (HEMIS), on the other hand, is the data management sub-system of the Directorate General for Higher Education (DGHE) within the BEMIS. It manages data from the higher education institutions (HEIs) and the DGHE, which are needed for policy and decision-making regarding higher education in BARMM. The HEIs' compliance, therefore, regarding current and future HEMIS data requirements cannot be overemphasized.

- 4. In this connection, all presidents/chancellors/superintendents/administrators of State Universities and Colleges (SUCs), Private Higher Education Institutions (PHEIs), Ministry-Supervised Higher Education Institutions (MSHEIs), and Local Universities and Colleges (LUCs) in BARMM are hereby directed to submit the following data using the annexed matrix in MS Excel format:
 - a. 1st Semester AYs 2023-2024 Summary of Total Enrolment Per Program and Per Gender (Annex A);
 - b. 1st Semester, Number of Enrolment Per Program, Year Level and Gender AY 2024-2025 (Annex B);
 - c. AYs 2022-2023 & 2023-2024 Number of Graduates Per Program (Annex C);
 - d. AY 2024-2025 Number of Faculty (Annex D);
 - e. AY 2021-2024 Number of Board Examination Passers (Annex E); and
 - f. AY 2023-24 Number of Building Infrastructures AY 2023-2024 (for MSHEIs only) (Annex F).

- 5. The HEMIS/Data Management Section of the DGHERO shall diligently follow up and assist the HEIs with their prompt, complete, accurate, and valid submissions.
- 6. Following the relevant provisions of CHED Memorandum Order No. 45, s. 2016 with the subject: Annual Higher Education Data/Information Collection, this Ministry shall apply the principle of reciprocity relative to these data requirements. Non-compliant HEIs:
 - a. shall be excluded from the Official List of Authorized Higher Education Institutions (HEIs) in BARMM published on the BEMIS official website;
 - b. shall not be accommodated in terms of their data request with the MBHTE for research and/or other purposes;
 - c. shall not be eligible as participating HEIs in the implementation of the Access to Higher and Modern Education Scholarship Program (AHME-SP); and
 - d. shall not be eligible to enjoy or participate in the programs, projects, and activities of the MBHTE, the Commission on Higher Education (CHED), and the CHED Higher Education in the Context of Bangsamoro Organic Law (HECBOL) Project; and
 - e. For non-compliant SUCs, their request for a Certificate of Program Compliance (COPC) with MBHTE shall not be entertained.
